ORDER

The Mahatma Gandhi University Under Graduate Programmes (Honours) Regulations, 2024 (MGU - UGP (Honours)), have been approved, vide paper read as (1) above, for the commencement of Honours Under Graduate Programmes from the academic year 2024 - 2025 in the affiliated colleges of the university in accordance with the guidelines of UGC and KSHEC.

Clause 8 of the said Regulations provides ample scope for Re-admission and Scheme Migration. However, provisions for readmitting students discontinued from CBCS 2017 Regulations were not specified concurrently. Hence, the matter has been placed before the Academic Council for consideration.

The Academic Council at its meeting held on 30.09.2024, vide paper read as (2) above, resolved to, amend the MGU-UGP (Honours) Regulations, 2024 - Clause 8 as follows:-

"Clause 8. iv: Re-admission from CBCS 2017 Regulations - Students who take re-admission to the MGU-UGP (Honours) Regulations, 2024 shall appear for internal and external examinations of all theory and practical courses of previous semesters which if she/he had completed under the CBCS 2017 Regulations. Students can avail this facility from the second semester to the sixth semester."

Orders are issued accordingly.
