ORDER

The Kerala State Higher Education Council has mandated the inclusion of a Multi Disciplinary Course based on the text book, *Knowledge Systems of Kerala*, in the curriculum of Honours Undergraduate Programmes.

The matter was brought into the consideration of the Syndicate Standing Committee - Academic Affairs, and on further consideration the Syndicate resolved to direct the Expert Committees of various Language Disciplines except Sanskrit to frame the syllabus for Multi Disciplinary Course based on the textbook *Knowledge Systems of Kerala*, in the third semester MDC basket from the Academic year, 2026-2027 (2025 admissions onwards).

In accordance, the Expert Committees of Arabic, English, Malayalam, Tamil and Hindi, submitted proposals of the Syllabi for the following Multi Disciplinary Courses,

1. Arabic : MG3MDCARB201 : Kerala Knowledge Systems

2. English : MG3MDCENG201 : Knowledge Systems of Kerala

3. Hindi : MG3MDCHIN201 : -ज्ञान के आईने में केरल (Kerala in the Mirror of Knowledge)

4. Malayalam : MG3MDCMAL201 : കേരളീയ വിജ്ഞാന വ്യവസ്ഥകൾ

5. Tamil : MG3MDCTAM201 : കേരളപ് പണ്പാറ്റ (Kerala Panpaadu)
